5. Organisation and operation of the budgetary body

5.1. Order of appointment of the head of the budgetary body:

HUN-REN SZTAKI is directed by a single person, and on the basis of Act I of 2012 on the Labour Code, its activities are managed by the Director as an executive employee.

The Director is appointed by the President of HUN-REN Centre for an indefinite term and HUN-REN Centre exercises the employer's rights over the Director. The procedure for the selection of the Director and the manner of exercising other employer's rights are regulated by the President of HUN-REN Centre in internal rules.
